- orientation portrait A4;
- line spacing single.
- 1. The index of the universal decimal classification (UDC) is given on the left above the information about the author.
- 2. Name and surname of the author/authors, company, country are located under the title font style Times New Roman 12.
 - 3. Author/authors e-mail centered, font style Times New Roman 12.
 - 4. Title of the paper font style Times New Roman 14, bold, centered.
- 5. **Abstract** (150 words) located in two intervals under the information about the author / authors. Abstract should summarize the following information presented in the article: goal, method, results, conclusion. Font Times New Roman 10, single spacing.
- 6. **Key words** (not more than 5) are located in one interval under the annotation. Font 10 Times New Roman, single spacing. The main text of the article is separated from the keywords in one interval.
 - 7. The main text of the article Font 12 Times New Roman.
 - 8. The article should be at least 3000 words and not more than 5000 words.
- 9. All tables and figures are included in the text and must have end-to-end numbering. Under the tables and drawings, you must specify the source from which the drawing or table is taken (Source: author, book, journal, etc.). For drawings, the JPG format is used. Times New Roman 10, single spacing.
